2	 Report made of 91.3 % of green projects and 8.7 % of social projects, with a greater number of project categories financed than previously. 11 new projects. Follow-up on GreenGOV : Launch of a study on green finance practices in Europe. Integration of two Ukrainian regions. Next meeting in November 2024 in South-Romania.
3	 Follow-to the ex-post impact report on projects featured in the 2015 reporting: 6 months delay on the report as the LOTI balance sheet for the ligne 14 extension to Mairie de Saint-Ouen is not available.
4	 EIB reporting project: Preparation of an EIB reporting for the drawing of the credit line based on the reporting sheets.
5	 5. ESG communication project: Presentation of a projet centered around the SDRIF-E, in partnership with CACIB, planned for September 2024. Presentation of an ESG library project.
6	 6. Current topics : Presentation of the 2024 Finances Directorate Awards, granted by CFI. New access for the regional finance portal, and redesign project for the webpage.
List of decisions	 The committee has reservations regarding: The absence of projects from the environment directorate in the 2023 allocation and impact report. Those projects have finally been integrated.
